Election Results

Thank you to all of you who helped with the local School Board election. Our PAC team, led by Francisca Montes and aided by our CTA field rep Zev Kvitky put together one of the strongest campaigns we have seen in a long time. Members knocked on 2,000 doors and were also able to reach most Hayward voters through our partners at the Alameda Labor Council and Hayward Democratic Party.

While we are frustrated with the slow pace of vote counting in Alameda County, we cannot accept results from this close contest with fewer than a third of votes counted. We hope that in the coming days, the pace picks up and winners can be confidently announced for the HUSD board.

As for national election news, no matter the challenges we may face in the coming years, HEA, CTA and NEA will continue to be the strong advocates for public education and our students that we so proudly serve! We are grateful to have a union that can defend our members and students.

Community Schools

We have heard that newly named Community Schools received notice from the District that as a Community School, their first step is to form site teams. In essence, HEA FRA reps should run the HEA elections for members of the site committee in the same way as SBDM teams and co chairs. Within the election process, the ballots should indicate that one of the folks elected will be the co-chair for the site team e.g. highest vote getter, the one person interested etc. This is the tentative language regarding Community Schools. We don't anticipate any changes and are scheduled to submit final signatures Tuesday of next week. Please do not hesitate to reach out if you need clarification.

SBDM MAA Allocations

The District recently sent MAA allocations to SBDM team co chairs. It is the one pot of money that SBDM is responsible for. Please note that any monies not spent in prior years rolls over. If you did not receive the allocations for your site, please let HEA know and we will make sure to get them to folks.



TK MOU Update

Please refer to last week's Friday Follow-up for previous TK MOU updates.

Update: While Ed Services honored the annual TK classroom allocation of \$1,000 to meet and support the foundational requirements (PTKLF), and the purchase of consumable materials, they put limitations on where purchases could be made e.g. no purchases from Lakeshore. They also restricted spending related to the supplemental materials. We have asked about these restrictions in spending opportunities. We have also heard that there are no TK EL classifications because the assessment tools are not developmentally appropriate. We will ask what the response related to this is as well. The District has said that we can send questions and they will create an FAQ.

ELD/ALD

Discussions continue with the District about ELD/ALD class size maximums. HEA's position is still that ELD/ALD "class sizes" should be within the class size maximums stated in the contract. Also, we have heard that some ELD/ALD classes have 3 grade levels. We are looking into this since, nowhere in the contract does it say that elementary combination classes are more than 2 grade levels (except for Sp Ed classes). We will let you know the outcome of the discussion.



Mandated Trainings / PUBLIC WORKS

We have heard that some folks at sites have not yet completed the Public Works/Mandated training. The District has repeatedly stated that they have this matter under control and administration at the site is supposed to provide release time for folks who did not yet complete it

and/or provide time at staff meetings or PD to complete the training. <u>They have asked that we not do anything on our own to meet the timeline and they will remind the administration.</u>

COVID Tests Available

As of late September, residential households are eligible for another order of 4 free at-home tests from <u>USPS.com</u>. Each order includes 4 individual rapid antigen COVID-19 tests. <u>COVIDTests.gov</u> has more details about at-home tests, including extended shelf life and updated expiration dates.
