Social Security Fairness Is Now a Law!!

It's official! On Sunday, union leaders across the country celebrated as President Biden signed the Social Security Fairness Act (H.R. 82) into law, giving over 280,000 Californians and 2 million Americans the full retirement they earned. H.R. 82 finally repealed the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), the unfair penalties that denied retired educators and other public service workers their full Social Security benefits. This was a 40-year fight led by union members across the country, including many CTA members. And when we fight, we win! See the latest CTA Bulletin for more information!

Corrective Repairs at 24411 Amador St. "District Office"

On Tuesday, January 7th, the School Board held an emergency meeting regarding "corrective actions" needed to remedy the sewage and mold problems at the Elmhurst and District Office.

It was a short and concise meeting.

Here are the highlights;

- The Board unanimously (5-0) approved the resolution to seek repairs for the district office
- Trustees Prada, Bruckner-Carrillo, and Oquenda requested regular updates on the repairs and work progress
- Bruckner-Carrillo emphasized the importance of prioritizing union-affiliated companies for the repairs
- The Superintendent mentioned the possibility of relocating district office staff to the HUB or the Adult School ("LOL")
- The Board questioned why Maintenance Operations (MO) had not addressed staff concerns regarding the persistent smell, carpet, and sewage issues. No response was provided
- A follow-up Board meeting is scheduled for January 15th to review updates. They advised against involving more items in the January 29th meeting
- Both the public and Board members requested continuous air quality testing, with results made publicly accessible

For now, both buildings are closed, folks are working from elsewhere, and the print shop is closed. We will continue to advocate for the safety and rights of our members in the Elmhurst and District office. We have suggested that, before returning to either building, the District M and O hold a meeting with folks so that any questions and/or assurances can be asked/made prior to a return.

HUSD Budget Update: Prepare to Defend Our Schools!

<u>Background</u>: Hayward Unified's First Interim Financial Report was presented on December 16, 2024, with a Negative Certification recommendation, meaning the District cannot meet its current financial obligations for the next three years. This is a change in the status from the District's prior "conditional" status because the budget deficit has increased from \$31 to \$55 million dollars. The District estimates that cuts of \$10 to \$12 million must be approved by Spring to avoid possible County actions against the District.

HEA has recommended cost-saving measures to address budget cuts in the past, and has suggested they be implemented again to reduce expenditures: hiring freezes, cap/freeze funds for conferences, consultants, and contracts for services, freeze discretionary funds, and more. To

date, the District has only implemented a hiring 'frost'. It appears that the District is waiting to complete the Townhalls and Community surveys prior to taking action. The survey is appreciated, but there's no need to wait to start acting responsibly. We know further steps can and should be taken immediately.

As of our last Budget Forum meeting, the District did not believe an early retirement incentive would be beneficial. At HEA's urging, the District is reconsidering the possibility of a Golden Handshake. They are planning to meet with HEA and Keenan and Associates (the company that provides the analysis related to Golden Handshakes). We will let members know as soon as possible if any incentives will become available for retirement in 2025.

HEA will continue to advocate on behalf of all of its members for the sake of our students and quality public education. HEA has always maintained the position that any cuts should be as far away as possible from our students, classrooms, sites, those who provide direct instruction as well as TOSAs who provide the backbone of our educational programs. In other words, we all matter-we all make a difference and without any one of us in HEA, our students will be negatively impacted.

Our work has never been more important – or challenging – than it is today. We can't afford any reductions to our membership when the needs of our students and communities continue to grow. Let us remember now, more than ever — to STAND UP, STAND STRONG and STAND TOGETHER and to continue to provide the education that all of our students and families deserve.

<u>**UPDATE**</u>: The **District** (the Superintendent and Amy Nichols CFO) has called for a "Budget Solutions" meeting with us later today. We will share what we learn at this meeting.

In addition, AEOTE and HEA's **CTA** representatives Chaz Garcia and Zev Kvitky have enlisted the assistance of the CTA Bargaining Specialist Daryl Hemenway to analyze HUSD budget & finance documents to identify potential strategies to reduce budget cuts we expect to be announced soon. They have scheduled a 1-hour meeting for HEA and AEOTE to hear of the findings of the analysis and discuss some suggestions from CTA to minimize the scope and impact of any layoffs and or cuts.
